I move that this session of the Executive Clergy Session of the Tennessee-Western Kentucky Annual Conference be conducted online, as approved by the Bishop and a majority of the district superintendents, who may, as necessary change the place of annual conference pursuant to Paragraph 369.5 of the Book of Discipline 2016;



I move that the bar of this Executive Clergy Session include the registered participants in this electronic (ZOOM) platform.



I move that the agenda of the Executive Clergy Session is the agenda published in advance of this meeting and that the Bishop is permitted to make changes to the agenda as needed for the good of the order;

I move that those who are authorized to participate in the inaugural Executive Clergy Session of the Tennessee-Western Kentucky Annual Conference of the United Methodist Church [2016 BOD ss. 601, 602, 603, 604, 605, 606] on June 1, 2022, agree that they consent to proceed in a virtual Executive Clergy Session using remote technology; and that they further consent that all decisions made in this session have the same effect and authority as decisions made by an in-person session of the executive clergy session conducted under the Constitution of The United Methodist Church [Division Two, Section VI, Article 1 (para. 32); Article II (para.33); Article III (para. 34); Article IV (para. 35); Article V (para.36)], under the laws of the Church, and under the Rules of Order of the Tennessee-Western Conference; and finally that they consent that all such decisions made in this session are and will be legal and binding actions of the Tennessee-Western Kentucky Annual Conference”.

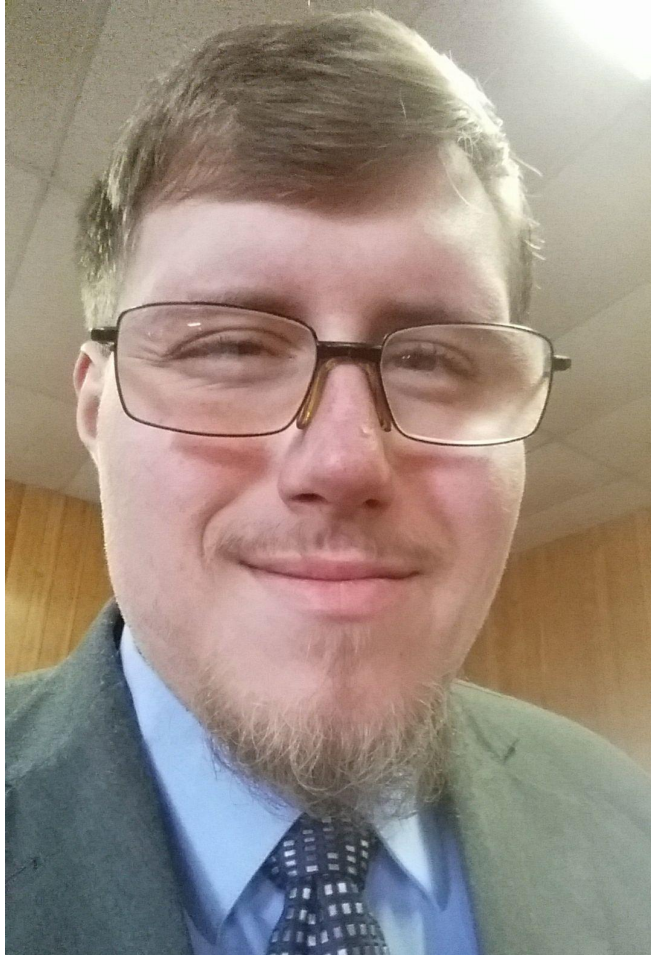

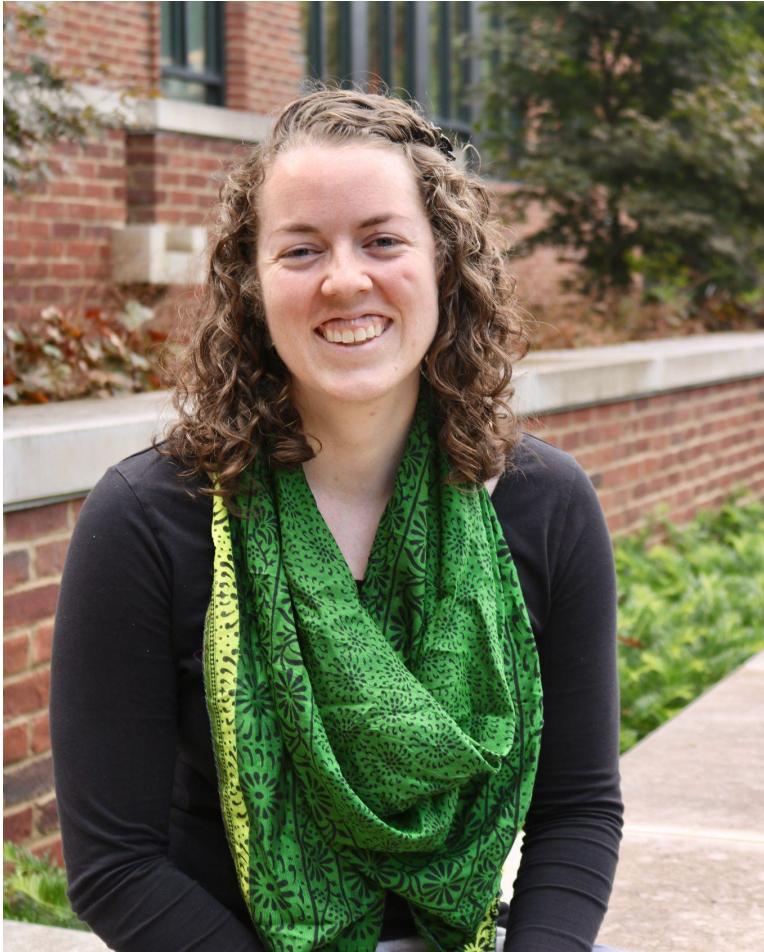
