

**Resolution Requesting Charge Line Changes  
Tennessee-Western Kentucky Annual Conference  
June 19-21, 2023**

**WHEREAS**, the Tennessee-Western Kentucky Conference Charge lines were reviewed by each of the eight district superintendents to determine the best way to provide the most effective pastoral leadership for every congregation within each district;

**THEREFORE, LET IT BE RESOLVED**, that the following charge line changes listed by district are needed:

**Caney Fork River District**

The Clarkrange-Zion Hill Charge be dissolved, and the Monterey-Clarkrange Charge be created.

The Jamestown-Forbus Circuit Charge be dissolved, and the Jamestown Charge be created.

The Smithville-Bright Hill Charge be dissolved, and the Keltonburg-Smithville-Webbs Chapel Charge be created.

**Cumberland River District**

The Matthews Memorial Charge and the Ruth Ensor Charge be dissolved and the Matthews Memorial-Ruth Ensor Charge be created.

**Harpeth River District**

The Highland-Mt. Lebanon: Highland Charge composed of Highland United Methodist Church, be dissolved, and the Highland Charge, composed of Highland United Methodist Church, be created.

The Highland-Mt. Lebanon: Mt. Lebanon Charge, composed of Mt. Lebanon United Methodist Church, be dissolved, and the Mt. Lebanon Charge, composed of Mt. Lebanon United Methodist Church, be created.

The Santa Fe Circuit (Goshen United Methodist Church, Godwin Chappell United Methodist Church, Santa Fe Methodist Church, and Theta United Methodist Church) be dissolved and the Santa Fe Charge be created to be comprised of Goshen United Methodist Church, Godwin Chappell United Methodist Church, and Theta United Methodist Church.

**Metro District**
