**CANEY FORK RIVER DISTRICT**

The Keltonburg-Webb's Chapel-Smithville Charge (consisting of Keltonburg UMC, Webb's Chapel UMC, and Smithville UMC) be dissolved, and the **Keltonburg-Webbs's Chapel Charge** (consisting of Keltonburg UMC & Webb's Chapel UMC), and the **Smithville Charge** (consisting of Smithville UMC) be created.

The Grace-Palmer Charge (consisting of Palmer UMC and Grace UMC) be dissolved, and the **Grace Charge** (consisting of Grace UMC), and the **Palmer Charge** (consisting of Palmer UMC) be created.

**STONES RIVER DISTRICT**

The Harris Chapel-Pleasant Grove Charge (consisting of Harris Chapel UMC and Pleasant Grove UMC) be dissolved, and the **Harris Chapel Charge** (consisting of Harris Chapel UMC) be created.

**HARPETH RIVER DISTRICT**

The New Prospect-Mars Hill (consisting of New Prospect and Mars Hill UMCs) be dissolved and the **Mars Hill Charge** be created, consisting of Mars Hill UMC.

The Dresden- Pisgah Charge be dissolved, and the **Dresden-Freeman's Chapel** charge be created.
